


CERF ETHOS



APPLICATIONS - 404 as of June 23rd


To date, we have been able to help 188 unique households stay sheltered and connected to resources. Of the 404 applications received, 216 are renewals and 280 grants have been awarded. The large influx of renewal applications we saw in May occurred again in June and we have 77 open applications from the 82 received. While some applicants have begun a slow, part-time return to work, we are not seeing a meaningful end or a return to pre-COVID levels.






We continue outbound calls to former applicants to see if they need to reapply. In this way, we can manage the workflow and the impact to the team resources. Given the invoicing dates from the utility companies and the due dates for rent from landlords, the last 2 weeks of each month will remain unavoidably busy for the CERF team.









The 280 approved cases have received grants totaling just over \$270,000. The current average award rose again this week to \$1,015.75. We continue to receive initial applications however they represent less than 5 applications per week. At this award level and with our current funding, we will be able to help approximately 160 more applicants or times and have sufficient funding for approximately 6 weeks at the current average rate of applications received – 27 per week.

PROCESS

We continue to adjust our existing process to accommodate a phased return to work. We are documenting continued unemployment or under-employment and working with applicants so we can support what will be a gradual return to work for most. Few, if any, will go from completely unemployed to fully re-employed so we want to make that transition as smooth as possible for applicants.



For each renewal application, case managers track changes in earnings and work with applicants to determine which bills they would like CERF to consider. If funding permits, each month as applicants income increases, the CERF award will decrease until applicants are able to earn their pre-COVID income.

The New Jersey COVID-19 Emergency Rental Assistance Program will open for applications beginning July 6th and the application window will remain open until July 10th. An unknown number of residents will be chosen via computerized lottery for up to 6 months of rental support. There are no plans for a second application window and while phone assistance will be available, it seems unlikely to be a viable submission option.



Without this leadership and legal talent, many young people faced the frightening prospect of being forced to leave the United States – the country that they have called home. Perhaps equally important to the hope for dreamers in the ruling, is the accountability for the federal government. The court's opinion reminded us all that capricious and arbitrary decisions are disallowed under the Administrative Procedure Act.
